Engineering Professional Practice Requirements

Enabled: Statistics Tracking

All UQ Bachelor of Engineering, Bachelor of Engineering (Honours), Bachelor of Engineering (Honours)/Master of Engineering, Master of Engineering and Master of Engineering (Professional) students must complete 430 hours of Engineering Professional Practice. This includes

1. Maintain an up-to-date record of your professional practice hours via the EPP System/EPP Hub* and,

2. Submit reflections on your Engineering Professional Practice in line with the Engineers Australia Stage 1 Competencies. Reflections must be submitted on this reflections template.

Please note that <u>ALL</u> engineering professional practice requirements (hours and reflections) must be submitted **as per the 2025 submission deadlines below**. If these requirements are not met, you will not be eligible to graduate. Where requirements are dependent on course completion, your professional practice status will remain incomplete until course grades are released.

*EPP Hub will be available from Semester 1 2025. You can continue to claim your EPP hours in the EPP System in the meantime.

2025 submission deadlines

Semester 1, 2025 Graduation

- Professional Practice hours claims must be **submitted** in your EPP Hub by 4:00 PM Friday 2 May 2025
- Reflections must be submitted through Blackboard by 4:00 PM Friday 2 May 2025. Reflections submitted by the deadline will be marked in time for graduation checks. No extension requests will be granted

Semester 2, 2025 Graduation:

- Professional Practice hours claims must be submitted in your EPP Hub by 4:00 PM Friday 26 September 2025
- Reflections must be submitted through Blackboard by 4:00 PM Friday 26 September 2025. Reflections submitted by the deadline will be marked in time for graduation checks. No extension requests will be granted
